## Consider donating to AzCA through your paycheck.

**Q: Why should I give to AzCA?**

**A:** Staff giving makes a HUGE difference to outside funders. Having strong participation and commitment from our employees shows that we truly believe in the work that we provide for Arizona's children and families.

**Q: How much should I give?**

**A:** It's not about how much you give. We just ask that you give. A dollar a paycheck, \$5 a paycheck — it all adds up! Think about it... a dollar from each paycheck is only \$26 for the year!

**Q: What is the Arizona State Charitable Organization Tax Credit (formerly known as the Working Poor Tax Credit)?**

**A:** Your donation to AzCA may qualify for a dollar-for-dollar tax credit on your Arizona state income tax return. Taxpayers filing as "single" and "head of household" status may claim a maximum credit of \$400. Those who file as "married filing joint" may claim a maximum credit of \$800.

Recurring Gift Examples:

- \$3.85 per paycheck totals approx. \$100 each year
- \$7.70 per paycheck totals approx. \$200 each year
- \$15.40 per paycheck totals approx. \$400 each year

**Did you know? You may be able to reduce your Arizona state taxes  
and support our kids and families.**

**You may be eligible for a dollar for dollar tax credit,  
up to \$400 for individuals and \$800 for couples filing jointly.**

*You no longer need to claim itemized deductions in order to claim a credit!*

Under a State of Arizona tax credit program that benefits charitable organizations that serve the Working Poor, donors to Arizona's Children Association can claim a personal tax credit for the amount of their contribution (up to \$400 for individuals and \$800 for couples filing jointly).

**This is not just a tax deduction - it is a tax credit that reduces the amount you owe...dollar for dollar!**
